These cases come before the Commission on appeals filed by the Whatcom County Employees for Wage Equity (WCEWE), seeking to overturn the order of dismissal issued by the Executive Director.¹ The WCEWE assigned error to Findings of Fact 3, 4, 5, 6, and 7, Conclusions of Law 2 and 3, and Orders 1 through 5. The WCEWE and Teamsters Local 231 (which intervened as the incumbent exclusive bargaining representative of the employees involved) filed appeal

briefs. The employer was not required by rule to file an appeal brief, and it did not do so.

After a thorough review of the record and the parties' arguments on appeal, we affirm the Executive Director's decision. We agree with both his factual and legal analysis, where the WCEWE declined to stipulate to the propriety of the bargaining unit it proposed in its petition and then filed four severance petitions affecting employees within the bargaining unit it originally proposed. Nothing submitted on appeal would cause us to change the analysis or the outcome of the Executive Director's decision. Thus, we incorporate that decision here as the basis for our decision.

NOW, THEREFORE, it is

ORDERED

The order issued by the Executive Director in the above-captioned cases is AFFIRMED and adopted as the final order of the agency.
