On March 20, 2008, Office and Professional Employees International Union, Local 8 and Service Employees International Union, Healthcare 1199NW jointly filed a petition for investigation of a question concerning representation with the Public Employment Relations Commission, involving certain employees of Kennewick Public Hospital District 1. As a result of preliminary processing of the petition, the Commission determined the question concerning representation, and issues concerning the eligibility of certain employees for inclusion in the bargaining unit were reserved for The tally indicated that Office and subsequent determination. Professional Employees International Union, Local 8 and Service Employees International Union, Healthcare 1199NW were entitled to certification in the matter, and that the reserved eligibility issues were not of a sufficient number to affect the outcome of the proceedings.

An interim certification was issued in this matter, as *Kennewick Public Hospital District 1*, Decision 10100 (PECB, 2008), for the bargaining unit described as:
