FINDINGS OF FACT

1. The above-named Petitioner timely filed with the Commission a petition for investigation of a question concerning representation of employees of the abovenamed employer; said petition was accompanied by a showing of interest which was administratively determined by the Commission to be sufficient; and the employer declined voluntarily to extend recognition to the Petitioner as the exclusive bargaining representative of its employees.

2. These representation proceedings were conducted by the Commission in the bargaining unit described as: All clerical employees of the Snohomish County Sheriff's Department, including property clerks, security clerks, clerk typists, clerks, receptionists, social service counselors, non-commissioned offices (custodial-janitors) and warrant service officers; EXCLUDING the Sheriff, Undersheriff, Chief Criminal Deputy, Chief Civil Deputy, Jail Superintendent and Inspector.

THIS UNIT IS AMENDED BY AGREEMENT OF THE PARTIES TO INCLUDE Warrant Service Officers following a cross-check among the accreted employees.

 3° . All proceedings were conducted under the supervision of the Commission in a manner designed to afford the affected employees a free choice in the selection of their bargaining representative, if any; a tally of the results was previously furnished to the parties and is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

CONCLUSIONS OF LAW

The unit described in finding of fact number 2 is an appropriate unit for the purposes of collective bargaining within the meaning of RCW 41.56.040 and all conditions precedent to an amendment of certification have been met.
