#### FINDINGS OF FACT

1. The above-named petitioner timely filed with the Public Employment Relations Commission a petition for investigation of a question concerning representation of employees of the above-named employer; said petition was accompanied by a showing of interest which was administratively determined by the Commission to be sufficient; and the employer declined voluntarily to extend recognition to the petitioner as the exclusive bargaining representative of its employees.

2. These representation proceedings were conducted by the Commission in the bargaining unit described as:

ALL FULL TIME AND REGULAR PART-TIME POLICE OFFICERS EMPLOYED BY THE EMPLOYER, EXCLUDING: THE CHIEF OF POLICE, SUPERVISORS, CONFIDENTIAL EMPLOYEES AND ALL OTHER EMPLOYEES.

3. All proceedings were conducted under the supervision of the Commission in a manner designed to afford the affected employees a free choice in the selection of their bargaining representative, if any; a tally of the results was previously furnished to the parties and is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

The employees of the above named employer employed in the appropriate collective bargaining unit described in finding of fact number 3 have chosen:



The parties waive hearing, and request the Commission to determine the question concerning representation by conducting a cross-check comparing authorization cards individually signed and dated by employees or current membership records submitted by the employee organization against employee-signed documents contained in the employment records of the employer.

The parties agree to be bound by the results of the cross-check, as indicated in the certification to be issued by the Commission. If the results of the crosscheck indicate that a majority of the employees have authorized the petitioner to represent them, the employer will recognize the petitioner as the exclusive bargaining representative of all of the employees in the bargaining unit. If the results of the cross-check indicate that the petitioner does not represent a majority of the employees in the bargaining unit, then the petitioner will refrain from seeking recognition or certification as the representative of employees in the bargaining unit for a period of one year following issuance of the certification by the Commission.
