FINDINGS OF FACT

- 1. The Washington Federation of State Employees filed a petition for investigation of a question concerning representation with the Public Employment Relations Commission, for the employees in the Fruit and Vegetable Inspection Program at the Washington State Department of Agriculture. The petition was timely filed and accompanied by a showing of interest which was administratively determined by the Commission to be sufficient. No other organization is known to claim to represent the employees involved.
- 2. The existing bargaining unit represented by the Washington Federation of State Employees is described as:

All employees, occupying a permanent, project, or seasonal position in the classified service within the Fruit and Vegetable Inspection Program of the Department of Agriculture with the exception of the Horticulture District Manager, Horticulture District Assistant Manager, Fruit and Vegetable Program Manager, and the secretary to the Fruit and Vegetable Program Manager.

3. All proceedings were conducted under the supervision of the Commission in a manner designed to afford the affected employees a free choice in the selection of whether they wished to be represented by the Washington Federation of State Employees in its existing bargaining unit. A confidential cross-check of employer and union documents has been conducted by the Commission staff and a tally of the results previously furnished to the parties is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

4. The existing bargaining unit represented by the Washington Federation of State Employees shall be modified to include the employees in the Fruit and Vegetable Inspection Program for a bargaining unit described as:

All non-supervisory civil service employees covered by Chapter 41.06 RCW and Chapter 41.80 RCW of the Washington State Department of Agriculture in the Fruit and Vegetable Inspection Program, excluding supervisors, confidential employees, WMS employees, and all other employees.

CONCLUSION OF LAW

The unit described in paragraph 4 of the foregoing Findings of Fact is an appropriate unit for the purposes of collective bargaining within the meaning of RCW 41.80.070.

	(1) Where a cross-check of records is to be conducted to determine a question concerning representation, the organization shall furnish agency original or legible copies of individual cards or letters signed and dated by employees in the bargaining unit within ninety days prior to the of the petition and indicating that the employees authorize the named organization to represent them for the purposes of collective bargaining, or furnish to the agency membership records maintained by the organization as a part of its business records containing the names of employee indicating those employees currently members in good standing. (2) The agency shall honor a valid revocation of authorization contained in an individual card or letter signed by the employee and furnish the agency by the employee. (3) The employer shall make available to the agency original or legible copies of employment records maintained as a part of its business recontaining the names and signatures of the employees in the bargaining unit. (4) Prior to the commencement of the cross-check, the organization may file and serve, as required by WAC 391-08-120, a request the question concerning representation be determined by a representation election. Any such requests shall be honored. (5) Where the organization files a disclaimer or a request for election after the commencement of the cross-check, the cross-check shall terminated and the organization shall not seek to be certified in the bargaining unit for a period of at least one year thereafter. (6) All cross-checks shall be by actual comparison of records furnished by the parties. The agency shall not disclose the names of employeing representation authorization in favor of or appearing on the membership rolls of the organization.
