FINDINGS OF FACT

- 1. The Organized Classified Association of Oroville/WEA filed with the Public Employment Relations Commission a petition for investigation of a question concerning representation for paraprofessional employees (including speech language assistant). The petition was timely filed and was accompanied by a showing of interest which was administratively determined by the Commission to be sufficient.
- 2. The existing bargaining unit represented by Organized Classified Association of Oroville/WEA is described as:
 - ALL FULL-TIME AND REGULAR PART-TIME CUSTODIAN, MAINTENANCE, BUS DRIVER AND SECRETARIAL EMPLOYEES (INCLUDING LIBRARY AND SATELLITE TECHNICIAN) OF THE OROVILLE SCHOOL DISTRICT, EXCLUDING SUPERVISORS, CONFIDENTIAL EMPLOYEES AND ALL OTHER EMPLOYEES.
- 3. All proceedings were conducted under the supervision of the Commission in a manner designed to afford the affected employees a free choice in the selection of whether they wished to be represented by Organized Classified Association of Oroville/WEA in its existing bargaining unit. A secret ballot election has been conducted by Commission staff and a tally of the results previously furnished to the parties is attached hereto; and no meritorious objections have been filed with respect to these proceedings.
- 4. The existing bargaining unit represented by Organized Classified Association of Oroville/WEA shall be modified to include the paraprofessional employees (including speech language assistant) for a bargaining unit described as:

ALL FULL-TIME AND REGULAR PART-TIME CUSTODIAN, MAINTENANCE, BUS DRIVERS, SECRETARIAL EMPLOYEES (INCLUDING LIBRARY AND SATELLITE TECHNICIAN) AND PARAPROFESSIONAL EMPLOYEES (INCLUDING SPEECH LANGUAGE ASSISTANT) OF THE OROVILLE SCHOOL DISTRICT, EXCLUDING SUPERVISORS, CONFIDENTIAL EMPLOYEES AND ALL OTHER EMPLOYEES.

CONCLUSION OF LAW

The unit described in paragraph 4 of the foregoing Findings of Fact is an appropriate unit for the purposes of collective bargaining within the meaning of RCW 41.56.

NOW, THEREFORE, it is

CERTIFIED

The paraprofessional employees (including speech language assistant) of Oroville School District have chosen:

ORGANIZED CLASSIFIED ASSOCIATION OF OROVILLE/WEA

as their representative for the purpose of collective bargaining with their employer.
