Pursuant to a stipulation of the parties entered into at hearing, findings of fact, conclusions of law and a direction of election were issued on October 28, 1980 accepting the stipulation of the parties and ordering a unit determination election among adult education employees of Lake Washington School District to determine the desires of those employees as to their inclusion in one of two appropriate bargaining units. The election was conducted by the Public Employment Relations Commission and a tally of ballots was issued, a copy of which is attached hereto. No meritorious objections have been filed with respect to these proceedings.


The majority of the employees of the above-named employer in the adult education voting group have indicated their preference for inclusion in the bargaining unit certified by the Public Employment Relations Commission in Decision No. 484-A EDUC, and that bargaining unit description is amended as follows:

Included: All full time and regular part time certificated employees of Lake Washington School District No. 414 employed in its Lake Washington Vocational-Technical Institute, including adult education employees. Excluded: Superintendent of Schools, administrative officers, confidential employees, certificated employees in the K-12 program and non-certificated employees.

Lake Washington Vocational-Technical Federation of Teachers, Local 3533, W.F.T., A.F.T., AFL-CIO is the exclusive bargaining representative of that bargaining unit.
