ORDER AMENDING CERTIFICATIONS

On June 25, 2012, International Association of Fire Fighters, Local 2950 (Local 2950) filed two unit clarification petitions seeking amendment of two bargaining unit certifications involving employees of King County Fire District 36 (employer). The amendment sought by Local 2950 was to reflect the results of a vote undertaken by the employees to affiliate and merge Local 2950 into International Association of Fire Fighters, Local 2099 (Local 2099). Accompanying each petition was evidence demonstrating that bargaining unit members did in fact affirmatively vote for the affiliation and merger. On July 3, 2012, Local 2950 filed a third petition seeking amendment to a third bargaining unit description in a manner similar to the earlier filed petitions. The three bargaining units at issue are described as follows:

Case 24923-C-12-1518 involves the "support services" bargaining unit. That unit is described as "All full-time and regular part-time non-uniformed personnel of the King County Fire District 36 (Woodinville Fire and Life Safety District) excluding supervisors, confidential employees and uniformed personnel." *King County Fire District 36*, Decision 9842 (PECB, 2007).

Case 24923-C-12-1519 involves the "uniformed staff" bargaining unit. That unit is described as "All full-time and regular part-time uniformed employees of the fire department except supervisory and confidential employees." *King County Fire District 36*, Decision 2341 (PECB 1985).

Case 24968-C-12-1522 involves the "battalion chiefs" bargaining unit. That unit is described as "All full-time uniformed battalion chiefs of the Woodinville Fire and Life Safety District, excluding all other employees of the employer." *King County Fire District 36*, Decision 4616 (PECB, 1994).

On July 5, 2012, the employer submitted a letter stating that it did not dispute that Local 2950 and Local 2099 provided the necessary documentation to meet the continuity and due process standards. The employer also stated that it did not oppose the transfer provided there was no attempt to modify or merge the existing bargaining units other than changing the name of the exclusive bargaining agent.

DISCUSSION

When a union seeks to amend a certification to reflect its affiliation with another labor organization, the union must show that union members were provided with due process and there is sufficient continuity between the pre- and post-affiliation union, thereby not raising a question concerning representation. *Skagit Valley Hospital*, Decision 2509-A (PECB, 1987), *aff'd, Skagit Valley Hospital v. PERC*, 55 Wn. App. 348 (1989). Generally, this Commission will not be inclined to overturn a union affiliation because of lack of "continuity" unless the organizational change has been so extensive that a certified bargaining representative has been displaced by a wholly different organization, or unless other, more traditional evidence exists that the successor organization lacks majority support. *Skagit Valley Hospital*, Decision 2509-A.

Due process concerns are satisfied where the petitioning labor organization provides documentation that a majority of employees were in favor of the transfer. The affiliation process

is completed with due process when there is notice to the employees, an opportunity to discuss, and an election conducted with reasonable precautions to maintain ballot secrecy.

The stated purpose of each petition is only to affiliate and merge Local 2950 into Local 2099, two separate locals within the umbrella of the International Association of Fire Fighters. Additionally, the scope of the three bargaining units to be represented by Local 2099 remains unchanged. Finally, Local 2950 provided a notarized statement demonstrating that the bargaining unit employees were permitted a vote on whether the employees wanted to affiliate and merge with Local 2099 and that 92.6% of the employees supported the merger. Because it readily appears that continuity and due process requirements have been satisfied in this case, the existing certifications are amended.

FINDINGS OF FACT

- 1. King County Fire District 36 is a public employer within the meaning of RCW 41.56.030(12).
- 2. International Association of Fire Fighters, Local 2950, is a bargaining representative within the meaning of RCW 41.56.030(2).
- 3. International Association of Fire Fighters, Local 2099, is a bargaining representative within the meaning of RCW 41.56.030(2).
- 4. On June 26, Local 2950 filed two petitions seeking to amend the existing certification of the support services and uniformed staff bargaining units to reflect that the employees voted to affiliate and merge Local 2950 with Local 2099.
- 5. On July 3, 2012, Local 2950 filed a petition seeking to the existing certification of the battalion chiefs' bargaining unit to reflect that the employees voted to affiliate and merge Local 2950 with Local 2099.

- 6. Accompanying all three of Local 2950's petitions was evidence demonstrating that the employees were provided an opportunity to vote on whether or not to affiliate and merge Local 2950 into Local 2099, and evidence demonstrating that the employees affirmatively voted for the affiliation and merger.
- 7. On July, 5, 2012, King County Fire District 36 filed a letter indicating that it had no opposition to the merger.

CONCLUSIONS OF LAW

- 1. The Public Employment Relations Commission has jurisdiction in this matter pursuant to Chapter 41.56 RCW.
- 2. Based upon Findings of Fact 6 and 7, Local 2950 provided due process to employees in allowing them to vote on whether or not to affiliate with Local 2099.
- 3. Based upon Finding of Fact 6, Local 2950 has affiliated with Local 2099.

ORDERED

- 1. Decision 11424 PECB clarifies the certification issued in *King County Fire District 36*, Decision 9842 (PECB, 2007), which is amended to reflect that the International Association of Fire Fighters, Local 2099, is now the exclusive bargaining representative of record. The bargaining unit description remains unchanged.
- 2. Decision 11425 PECB clarifies the certification issued in *King County Fire District 36*, Decision 2341 (PECB, 1985), which is amended to reflect that the International Association of Fire Fighters, Local 2099, is now the exclusive bargaining representative of record. The bargaining unit description remains unchanged.

3. Decision 11426 - PECB clarifies the certification issued in *King County Fire District 36*, Decision 4616 (PECB, 1994), which is amended to reflect that the International Association of Fire Fighters, Local 2099, is now the exclusive bargaining representative of record. The bargaining unit description remains unchanged.
