### FINDINGS OF FACT

- 1. The Association for Security Professionals filed with the Public Employment Relations Commission a petition concerning representation of employees of Energy Northwest. The petition was timely filed and accompanied by a showing of interest administratively determined by the Commission to be sufficient.
- 2. United Steelworkers, Local 12-369 is the incumbent labor organization that represented the petitioned-for employees and was granted status as intervenor in this proceeding.
- 3. These representation proceedings were conducted under the supervision of the Commission in the bargaining unit described as:

All uniformed security employees below the rank of sergeant employed by Energy Northwest.

4. All proceedings were conducted in a manner designed to afford the affected employees a free choice in the selection of their bargaining representative, if any; a tally of the results previously furnished to the parties is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

## **CONCLUSIONS OF LAW**

- 1. The unit described in Finding of Fact 3 is an appropriate unit for the purpose of collective bargaining within the meaning of RCW 41.56.060.
- 2. All conditions precedent to a certification have been met.

## **CERTIFICATION**

The employees of Energy Northwest in the appropriate bargaining unit described in Finding of Fact 3 have chosen

as their representative for the purpose of collective bargaining with their employer.
