CERTIFICATION AND  
CLOSING CASE

On October 27, 2016, Jeri Wood filed a representation petition seeking to decertify the International Association of Machinists and Aerospace Workers, District Lodge 160 (union) as the exclusive bargaining representative of a bargaining unit of Accounting Specialists and IT Support Technicians at Mason Transit Authority. The bargaining unit was certified under *Mason Transit Authority*, Decision 12339 (PECB, 2015), and described as:

All employees in the Mason Transit Authority Finance/IT Department in the Accounting Specialist and IT Support Technician job classes, excluding supervisors, confidential employees, and all other employees.

On January 11, 2017, the union filed a written disclaimer of all representation rights in the bargaining unit covered by the decertification petition. Thus, no question concerning representation remains to be determined.

ORDER

The certification issued by the Public Employment Relations Commission in *Mason Transit Authority*, Decision 12339, is WITHDRAWN, and the above-captioned matter is CLOSED.
