#### **FINDINGS OF FACT**

- 1. The Washington Public Employees Association filed with the Public Employment Relations Commission a petition concerning representation of employees of the Bellevue College. The petition was timely filed and accompanied by a showing of interest administratively determined by the Commission to be sufficient. No other organization is known to claim to represent the employees involved.
- 2. These representation proceedings were conducted under the supervision of the Commission in the bargaining unit described as:

All supervisory employees covered by Chapter 41.06 RCW and Chapter 41.80 RCW in the Program Specialist 5 job class working at Bellevue College, excluding non-supervisory employees, confidential employees, and all other employees.

3. All proceedings were conducted in a manner designed to afford the affected employees a free choice in the selection of a bargaining representative, if any; a confidential cross-check of employer and union documents has been conducted by Commission staff and a tally of the results previously furnished to the parties is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

## **CONCLUSIONS OF LAW**

- 1. The unit described in Finding of Fact 2 is an appropriate unit for the purpose of collective bargaining within the meaning of RCW 41.80.070.
- 2. All conditions precedent to a certification have been met.
