ORDER OF DISMISSAL

On February 22, 2017, Angela Gestring (Gestring) filed a representation petition with the Public Employment Relations Commission, seeking to decertify the Teamsters Local 117 (union) as exclusive bargaining representative of certain employees at the South Sound 911. On February 21, 2017, the union filed an unfair labor practice alleging the employer failed to bargain in good faith by unilaterally changing employee work locations, directly dealing with represented employees, unilaterally announcing that certain positions are available only to certain employees, and by circumventing the union. Processing of Gestring's petition was blocked pending the outcome of the union's unfair labor practice complaints.

On December 13, 2017, the union withdrew its unfair labor practice complaint. The closure of the unfair labor practice complaint lifted the blocked charge and processing of Gestring's representation petition continued. On February 28, 2018, a routine e-mail was sent to the parties concerning the processing of Gestring's petition now that the blocking charge had been lifted. Gestring failed to respond by the March 9, 2018, deadline.


On March 16, 2018, a show cause letter was sent to Gestring asking if she desired her petition to be processed. Gestring did not provide any response concerning this matter.

ORDER

The petition filed in the above captioned case is DISMISSED for the petitioner's failure to advance the processing of her petition.
