FINDINGS OF FACT

- 1. Jeff Augustus filed with the Public Employment Relations Commission a petition concerning representation of employees of the White Salmon Valley School District. The petition was timely filed and accompanied by a showing of interest administratively determined by the Commission to be sufficient.
- 2. The Public School Employees of Washington is the incumbent labor organization that represented the petitioned-for employees and was granted status as intervenor in these proceedings.
- 3. These representation proceedings were conducted under the supervision of the Commission in the bargaining unit described as:

All full-time and regular part-time classified employees of the White Salmon Valley School District, excluding supervisors, confidential employees, and extracurricular employees.

4. All proceedings were conducted in a manner designed to afford the affected employees a free choice in the selection of their bargaining representative, if any; a tally of the results previously furnished to the parties is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

CONCLUSIONS OF LAW

- 1. The unit described in finding of fact 3 is an appropriate unit for the purpose of collective bargaining within the meaning of RCW 41.56.060.
- 2. All conditions precedent to a certification have been met.

CERTIFICATION

The employees of the White Salmon Valley School District in the appropriate bargaining unit described in finding of fact 3 have chosen

NO REPRESENTATION

as their representative for the purpose of collective bargaining with their employer.
