ORDER WITHDRAWING RECOGNITION

On August 21, 1985, this agency certified the Redmond Police Officers' Association as the exclusive bargaining representative of the nonsupervisory law enforcement officers working for the City of Redmond Police Department. *City of Redmond*, Decision 2269-A (PECB, 1985). The bargaining unit is currently described as:

All full-time and regular part-time non-supervisory law enforcement officers employed by the City of Redmond, excluding elected officials, officials appointed for fixed terms, confidential employees and supervisors.

*Id.* On July 21, 2020, the union filed a written disclaimer of all representation rights concerning the nonsupervisory law enforcement officers bargaining unit, effective immediately.

#### **ORDER**

The certification issued in *City of Redmond*, Decision 2269-A is withdrawn and the Redmond Police Officers' Association no longer represents the nonsupervisory law enforcement officers working for the City of Redmond Police Department.
