FINDINGS OF FACT

- 1. The Washington Education Association filed a representation petition concerning employees of the Glenwood School District. The Public Employment Relations Commission (PERC) determined the petition was timely filed and accompanied by a sufficient showing of interest. No other organization claimed to represent the employees involved.
- 2. The bargaining unit is described as follows:

All nonsupervisory certificated employees employed by the Glenwood School District, excluding supervisors, confidential employees, classified employees, and all other employees.

3. PERC conducted election proceedings. The employees were given a free choice in the proceedings. The tally of results was provided to the parties. No meritorious election objections were filed.
