FINDINGS OF FACT

- 1. SEIU Healthcare 1199NW filed a representation petition concerning employees of the Valley Medical Center (King Public Hospital District 1). The Public Employment Relations Commission (PERC) determined the petition was timely filed and accompanied by a sufficient showing of interest. No other organization claimed to represent the employees involved.
- 2. The bargaining unit is described as follows:

All full-time, regular part-time, and per diem employees employed by Valley Medical Center in the following job classifications: Breast Imaging Technologist, CT Technologist, Electroneurodiagnostic Technologist, Electrophysiology Technologist, Interventional Radiology Technologist, Mammography Technologist, Medical Lab Technician, Technologist, Medical Technologist Coordinator, MRI Technologist, Nuclear Medicine Technologist, Nuclear Medicine Technologist Coordinator, PET Technologist, Polysomnographic Technologist, Pulmonary Function Technician, Radiologic Technologist, Respiratory Therapist, Surgical Technician, Ultrasound Technologist, excluding supervisors, confidential employees, temporary employees, and all other employees.

3. Because the more than 50 percent showing of interest threshold was met, PERC conducted card check proceedings. The employees were given a free choice in the proceedings. The tally of results was provided to the parties. No meritorious election objections were filed.

CONCLUSIONS OF LAW

- 1. The unit described in finding of fact 2 is an appropriate unit within the meaning of RCW 41.56.060.
- 2. Representation proceedings were conducted in accordance with RCW 41.56.095 and chapter 391-25 WAC.

Valley Medical Center (King Public Hospital District 1) employees in the bargaining unit described in finding of fact 2 have chosen

SEIU HEALTHCARE 1199NW

as their representative for the purpose of collective bargaining with their employer.
