FINDINGS OF FACT

- 1. The International Brotherhood of Electrical Workers Local 483 filed a representation petition concerning the Telecommunications Engineers at the City of Tacoma. The Public Employment Relations Commission (PERC) determined the petition was timely filed and accompanied by a sufficient showing of interest. No other organization claimed to represent the employees involved.
- 2. The existing bargaining unit, last certified in *City of Tacoma*, Decision 13186 (PECB, 2020), represented by the International Brotherhood of Electrical Workers Local 483 is described as follows:

All employees of the City of Tacoma in the following job classes: Communications Systems Technician I, II, III; Communications Systems Technician — Apprentice; Craft Helper; Electrical Inspector; Electrical Meter & Relay Technician — Apprentice; Electrical Meter & Relay Technician; Advanced Electrical Meter & Relay Technician; Electrical Trainee; Electrical Worker; Electrical Worker — Tree/Fire/Signal; Electrician; Energy Services Representative; Facilities Maintenance Mechanic; Facilities Maintenance Mechanic — Lead; Fire Maintenance Electrician Apprentice; Fire Maintenance Electrician; Heating & Air Conditioner Maintenance Mechanic Supervisor; Hydro Project Electrician;

Hydro Project Electrician Apprentice; Hydro Project Mechanic; Hydro Project Mechanic Apprentice; Hydro Utility Worker; Hydro Utility Worker – Senior; Line Clearance Tree Trimmer; Line Clearance Tree Trimmer – Senior; Line Electrician; Line Electrician – Apprentice; Line Electrician – Senior; Line Equipment Operator; Signal & Street Light Electrician; Signal & Street Light Electrician – Senior; System Power Dispatcher; Systems Operator Power Dispatcher Candidate; T&D Arborist; T&D Flagger; Tool & Equipment Room Coordinator; Utility Services Specialist; Wire Electrician; Wire Electrician – Apprentice; Wire Electrician – Senior; Wynoochee Project Maintenance Technician; Network Constructions Technician; and Telecommunications Utility Worker. Excluding confidential employees and all other employees.

- 3. Because the more than 50 percent showing of interest threshold was met, PERC conducted card check proceedings. The employees were given a free choice in the proceedings. The tally of results was provided to the parties. No meritorious election objections were filed.
- 4. The existing bargaining unit represented by the International Brotherhood of Electrical Workers Local 483 shall be modified to include the Telecommunications Engineers for a bargaining unit described as follows:

All employees of the City of Tacoma in the following job classes: Communications Systems Technician I, II, III; Communications Systems Technician - Apprentice; Craft Helper; Electrical Inspector; Electrical Meter & Relay Technician - Apprentice; Electrical Meter & Relay Technician; Electrical Pre-Apprentice; Electrical Worker; Electrician; Electrician - Lead; Energy Services Representative; Facilities Maintenance Mechanic; Facilities Maintenance Mechanic - Lead; Fire Maintenance Electrician Apprentice; Fire Maintenance Electrician; Heating & Air Conditioner Maintenance Mechanic Supervisor; Hydro Project Electrician; Hydro Project Electrician Apprentice; Hydro Project Mechanic; Hydro Project Mechanic Apprentice; Hydro Utility Worker; Line Clearance Tree Trimmer; Line Clearance Tree Trimmer - Senior; Line Electrician; Line Electrician - Apprentice; Line Electrician - Senior; Line Equipment Operator; Signal & Street Light Electrician - Apprentice; Signal & Street Light Electrician; Signal & Street Light Electrician - Senior; Substation Operator - Senior; System Power Dispatcher; Systems Operator Power Dispatcher Candidate; T&D Arborist; T&D Flagger; Tool & Equipment Room Coordinator; Utility Services Specialist; Wire Electrician; Wire Electrician - Apprentice; Wire Electrician - Senior, Wynoochee Project Network Maintenance Technician; Constructions Technician: Telecommunications Utility Worker; Telecommunications Engineer; and Telecommunications Engineer – Senior. Excluding confidential employees and all other employees.

CONCLUSIONS OF LAW

- 1. The unit described in finding of fact 4 is an appropriate unit within the meaning of RCW 41.56.060.
- 2. Representation proceedings were conducted in accordance with RCW 41.56.095 and chapter 391-25 WAC.

CERTIFICATION

City of Tacoma Telecommunications Engineer employees in the bargaining unit described in finding of fact 4 have chosen

INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS LOCAL 483

as their representative for the purpose of collective bargaining with their employer.
