FINDINGS OF FACT

- 1. The Pasco Commanding Officers Association filed a representation petition concerning the Police Lieutenant job class at the City of Pasco. The Public Employment Relations Commission (PERC) determined the petition was timely filed and accompanied by a sufficient showing of interest. No other organization claimed to represent the employees involved.
- 2. The existing bargaining unit, last certified in *City of Pasco*, Decision 13573 (PECB, 2022), represented by the Pasco Commanding Officers Association is described as follows:

All full-time and regular part-time Captains in the police department at the City of Pasco, excluding confidential employees, and all other employees.

- 3. Because the more than 50 percent showing of interest threshold was met, PERC conducted card check proceedings. The employees were given a free choice in the proceedings. The tally of results was provided to the parties. No meritorious election objections were filed.
- 4. The existing bargaining unit represented by the Pasco Commanding Officers Association shall be modified to include the Police Lieutenant job class for a bargaining unit described as follows:

All full-time and regular part-time Captains and Lieutenants in the police department at the City of Pasco, excluding confidential employees, and all other employees.

CONCLUSIONS OF LAW

- 1. The unit described in finding of fact 4 is an appropriate unit within the meaning of RCW 41.56.060.
- 2. Representation proceedings were conducted in accordance with RCW 41.56.095 and chapter 391-25 WAC.

CERTIFICATION

City of Pasco Police Lieutenant employees in the bargaining unit described in finding of fact 4 have chosen

as their representative for the purpose of collective bargaining with their employer.
