CERTIFICATION

On October 11, 1995, this agency certified Granite Falls Coaches/Extra-curricular Association/WEA as the exclusive bargaining representative of employees at Granite Falls School District. The bargaining unit is described as:

All extracurricular positions of the Granite Falls School District for which no certification is required, excluding confidential employees, supervisors, and all other employees.

*Granite Falls School District, Decision 5302 (PECB, 1995).*

On May 8, 2024, the union filed a written disclaimer of all representation rights concerning the extracurricular/coaches bargaining unit, effective immediately.

ORDER

Granite Falls Coaches/Extra-curricular Association/WEA's request is granted. The certification issued in Granite Falls School District, Decision 5302 (PECB, 1995) is withdrawn, and Granite Falls Coaches/Extra-curricular Association/WEA no longer represents the bargaining unit.
