### FINDINGS OF FACT

- 1. The Federal Way Education Association Education Support Professionals filed a representation petition concerning the Family Liaison employees at the Federal Way School District. The Public Employment Relations Commission (PERC) determined the petition was timely filed and accompanied by a sufficient showing of interest. No other organization claimed to represent the employees involved.
- 2. The existing bargaining unit, last certified in *Federal Way School District*, Decision 1660 (PECB, 1983), represented by the Federal Way Education Association Education Support Professionals is described as follows:
  - All full-time and regular part-time secretarial-clerical employees of the employer, excluding confidential employees, supervisors, and all other employees of the employer.
- 3. Because the more than 50 percent showing of interest threshold was met, PERC conducted card check proceedings. The employees were given a free choice in the proceedings. The tally of results was provided to the parties. No meritorious election objections were filed.

4. The existing bargaining unit represented by the Federal Way Education Association Education Support Professionals shall be modified to include the Family Liaison employees for a bargaining unit described as follows:

All full-time and regular part-time secretarial-clerical employees and Family Liaisons of the employer, excluding confidential employees, supervisors, and all other employees of the employer.

#### **CONCLUSIONS OF LAW**

- 1. The unit described in finding of fact 4 is an appropriate unit within the meaning of RCW 41.56.060.
- 2. Representation proceedings were conducted in accordance with RCW 41.56.095 and chapter 391-25 WAC.

### **CERTIFICATION**

Federal Way School District Family Liaison employees in the bargaining unit described in finding of fact 4 have chosen
